KEY INSIGHTS FROM OFCOM'S LATEST REPORT ON CHILDREN'S ONLINE LIVES

Ofcom's latest annual report offers a valuable overview of how children and young people are using digital technology, highlighting current and emerging trends.

Notable findings include:

- A continued rise in social media use among 3–5-year-olds, with four in ten now using these platforms—some independently, according to parents.
- Increased awareness among young people of how algorithms and recommendation systems shape their online experience.
- Half of 8–17-year-olds now using AI tools, reinforcing the need for education on safe and responsible use, along with increased staff awareness.
